REGULATORY CONTEXT

The recently enacted Law 21,595, on Economic and Environmental Crimes, contemplates a wide catalog of more than 200 crimes, which have a great impact on business and organizational policies, particularly, on the conduct of individuals who hold certain positions, in the exercise of their duties. its functions. In this way, natural and legal persons are criminally responsible for the commission of these crimes, which are classified into four categories, each of them including a detail of criminal types contained in various legal bodies. For its part, one of the particularities of this norm is that it increases sanctions that were previously merely pecuniary or administrative, to custodial sentences.

INDIVIDUAL CRIMINAL LIABILITY: Natural persons, as well as people who hold certain positions, within the framework of their functions, will be criminally responsible, from the publication of the law in the Official Gazette (August 17, 2023).

CRIMINAL LIABILITY OF LEGAL PERSONS (Law 20,393): The criminal liability of legal entities with respect to Economic Crimes comes into force in September 2024. The legislator extended the term, because the only way for organizations to be exempt from criminal liability is to develop a Crime Prevention Program. Cash Crimes.





Law 20,417, Environment Art. 37 bis

Imprisonment and Fine: a) Anyone who maliciously presents information in the EA of a project that hides or reduces environmental impacts. b) Anyone who maliciously splits their projects to evade the EIA system or change the entry route. c) Anyone who maliciously presents false or incomplete information to the MA Superintendency.

Penal Code Art. 305

Prison or Confinement, to which without having submitted its activity to an environmental impact evaluation, knowing that it is obliged to do so: a) Dumps polluting substances or solids, into maritime or continental waters, into the soil or subsoil and wetlands. b) Extract continental or maritime waters, or components of the soil or subsoil. c) Release polluting substances into the air.

Penal Code Art. 306

Prison or Confinement, which, having authorization to dump, release or extract substances, contravenes an emission or environmental quality standard, failing to comply with the measures established in a prevention, decontamination or environmental management plan; breaching an RCA or any condition associated with the authorization, having previously been administratively sanctioned.

Penal Code Art. 307

Prison or Confinement, who, having authorization to extract continental, surface or underground waters, extracts them in violation of the rules of their distribution, having been established by the authority the temporary reduction of the exercise of those rights, or in an area of prohibition for new aquifer exploitations.

Penal Code Art. 308

Prison or Confinement, which, by pouring, depositing or releasing polluting substances, or extracting water or components from the soil or subsoil, seriously affects the water, soil, subsoil, air, or animal or plant health, the existence of water resources. or the supply of drinking water, or wetlands by dumping soil or other solids into them.

Penal Code Art. 310

Prison or Confinement, which seriously affects one or more of the environmental components of a virgin region reserve, a national park, a natural monument, a national reserve or a wetland of international importance; or violating an RCA or without having submitted its activity to an environmental impact assessment and being obliged to do so, it will seriously affect a glacier.

PENAL RESPONSIBILITY OF JURIDICAL PERSONS


